Brief details of litigation viz. name(s) of the opposing party, court/ tribunal/agency where litigation is filed, brief details of dispute/litigation;	The Directorate of Revenue Intelligence (DRI), Bangalore Zonal Unit, had issued a Show Cause Notice ('SCN') dated July 18, 2018, demanding differential duty of ₹56.47 lakh along with applicable interest and an equivalent amount of penalty. The case pertains to the import of Smart Cards classified by the Company under Customs Tariff Heading (CTH) 8523 52 90, which attracts nil basic customs duty. However, the Department contended that the goods merit classification under CTH 8529, attracting 10% basic customs duty.
		The Additional Director General (Adjudication) confirmed the demand <i>vide</i> order dated April 28, 2020 ('Order'). An appeal was thereafter filed before the Customs, Excise and Service Tax Appellate Tribunal (CESTAT), Principal Bench, Delhi by the Company against the said Order. The Tribunal, vide its order dated September 23, 2025, allowed the appeal of the Company, setting aside the impugned Order.
